Accounts not paid in full within 30 days there forth will receive a disconnect notice from the City. Residents will have 7 calendar days to pay the account balance in full or water will be shut off. -All residents of the City of Imbler will be required to pay the monthly water rates regardless of whether they are hooked up as part of the City's fire protection plan and for continued maintenance to the water system.
